FIRST INFORMATION REPORT (FIR)

1. On 05 May 2026, a specific input regarding presence of SS/Lt Seimental Haokip, 22 year belonging to United Kuki National Army (UKNA) who was a key suspect in planning and killing of T.Khonomphai village chief in August 2025, in General Area M. Songgel, Churachandpur (Approx 5 Km North-West of Headquarter Veng) was received from 11 WEU. The input was further corroborated by own source and 9 FIT, ARFIU. Accordingly, a column of strength 01-01-20 ex 5 Assam Rifles under Maj Rahul Singh was swiftly launched at 1900 hours. The column was tactically divided into two parties: Cordon Party and Search Party. On reaching the location, the cordon party immediately established an outer cordon around the suspected house. Thereafter, the Search Party, led by Maj Rahul Singh, moved in to search the house. On spotting the Search Party, the suspect attempted to flee from his house in a gypsy. However, due to the swift and coordinated action by Maj Rahul Singh and his team, the individual was intercepted and overpowered after a chase. The cadre was successfully apprehended by 2005 hours and immediately brought to Company Operating Base. Thorough search of the apprehended individual and the vehicle (Gypsy) was carried out at the Company Operating Base. During the search One 9mm pistol along with a magazine and 06 live rounds was recovered from the vehicle. During preliminary questioning at Company operating Base, information was revealed regarding a likely weapon cache located at Gen Area Ukhai Loikhai (Approx 7 Km North-East of Henglep), Immediately, a team of strength 01-01-20 was launched from S Kholen Company Operating Base at 2100 hours to General Area Ukhai Loikhai. The party conducted a thorough search of the jungle area and at approximately 0400 hours, the team could locate the hideout. During detailed search of the hideout, a huge cache of concealed weapons and ammunition was recovered.


