FIRST INFORMATION REPORT (FIR)

1. Based on specific input received from 165 TA and further corroborated by 3 CIB and own sources regarding presence of a Kuki National Army (Burma) cadre Lal Thang John, 38 year, resident of Zouveng Churachandpur who had gone to Myanmar to join Kuki National Army (Burma) an operation was launched on 07 May 2026 at 200 hours un Gen Area Zouveng (3 Km North-East of HQ Veng). One column of 5 Assam Rifles under the command of Maj Anuj Mahajan, SM and one team of Churachandpur Police were launched to establish Mobile Vehicle Check Post (MVCP). Simultaneously a small party under Maj Rahul Singh was launched to keep the suspected house under surveillance. As soon as the individual moved out his house, the surveillance party maintained covert surveillance and tracked the movement of the individual while constantly relaying updates to the Mobile Vehicle Check Post (MVCP). Bothe the Mobile Vehicle Check Post (MVCP) parties swiftly moved and deployed on Tedim Road in General area Red Cross Junction to intercept the individual. One Mobile Vehicle Check Post (MVCP) placed itself in his approach route and the second Mobile Vehicle Check Post (MVCP) blocked his escaped routes. As soon as the individual reach the Mobile Vehicle Check Post (MVCP) location, he was identified and swiftly apprehended by the

alert troops at 2130 hours. He was immediately brought to the company operating base to avoid any internal security situation. Subsequent search of the apprehended individual resulted in recovery of one 9 mm Pistol.
