The brief fact of the case is that in connection with GD entry No. 42/KPI-PS/2026 dated: 10/03/2026; 9:30 pm, Night Patrolling Team of Kangpokpi-PS while patrolling on NH-2 towards Koubru Laikha as a part of normal daily duty, have found one loaded Tata Truck B/R No. AS01TC-9872 stopped at Kalapahar in suspicious manner at 6:30 pm. On checking the vehicle, no driver and other person found inside the vehicle. On being suspicious of kidnapping and ransom, then one team led by SDPO-Kangpokpi and NPT-1 move towards Koubru Laikha and keeping watch on the Truck. Similarly, one team led by OC/KPI-PS moves towards Daili village to keep watch on the Truck. The Truck at around 9:00 pm starts moving toward Koubru Laikha and then intercept by teams led by SDPO-KPI and NPT-1. After further enquiry and visiting the P.O, the Truck along with its driver, helper and guide brings to KPI-PS at 9:30 pm and their statement is recorded by NDO and then the Truck driver, helper and guide is released from KPI-PS by 1:00 am of 11/03/2026. The case is endorsed for preliminary enquiry to SI Hemjamang Khongsai of KPI-PS on 11/03/2026. The enquiry Officer after going through the complainant statement and recording statement of the transporter namely Gopal Chetri (24) yrs. s/o Ganesh Bahadur Chetri of Khatkhathi, Assam and the enquiry officer found some suspicion of being kidnapped for ransom by the unknown persons.
