REQUISITION FOR FIRST INFORMATION REPORT

On 22 May 26, a specific and actionable input was received from own sources regarding presence of three (03) United Kuki National Army (UKNA) cadres hiding inside a house.

Acting swiftly on the above intelligence, a joint operation comprising strength of 01-00-30 under a Column Commander ex Battalion Headquarter, Khuga, team of strength 01-01-02 and Manipur Police was launched in general area Nghathal (06 km North of Khuga) (Notified Area) at 1700 Hr on 22 May 26.

The columns were deployed near the suspected house for continuous monitoring & surveillance of the suspects. After positive visual confirmation of UKNA cadres hiding inside a house, the search party moved in to search the house. At 2115 Hr, two (02) suspected cadres were detained from the house.

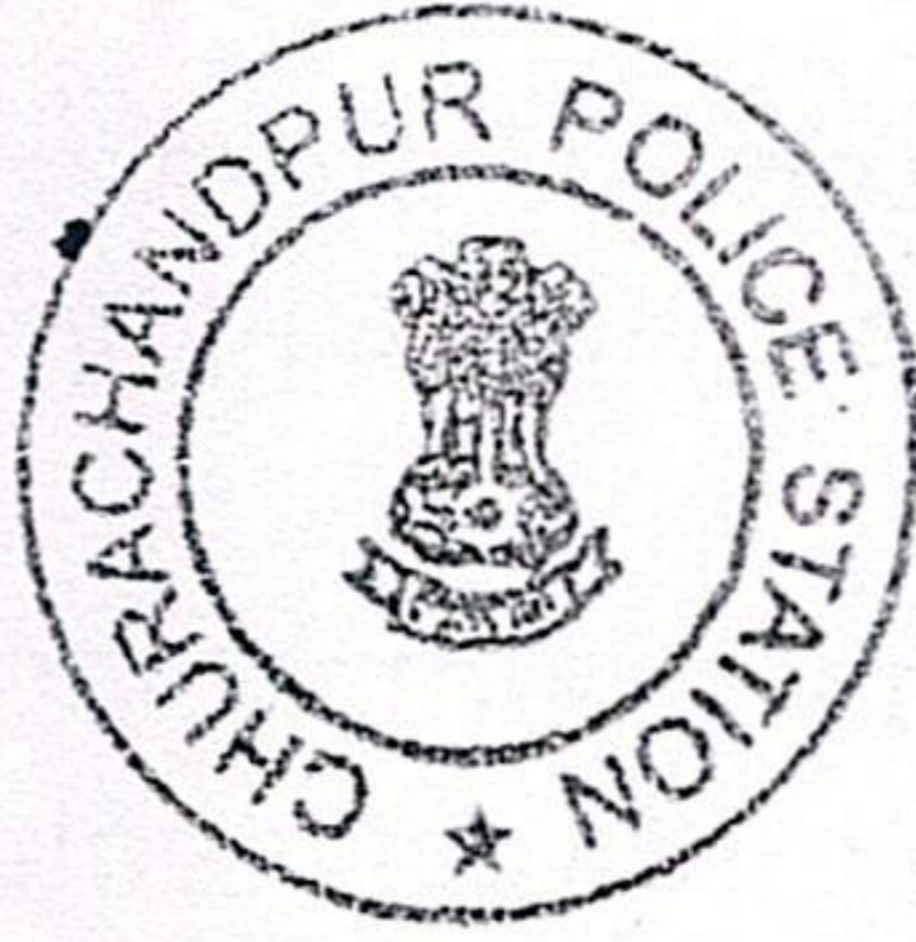
