Based on reliable input regarding the presence of an armed miscreant at Edenthur Rengkai Village, a combined team comprising two teams from CCP-PS and one column of 5 Assam Rifles, under the command of Shri Jay Barange, IPS, SDPO/CCP, conducted a joint operation in the suspected area on 23/05/2026 at around 8:00 PM.

During the operation, a search was conducted at the residence of Mr. Jehova Raja Dutta (24) years, s/o Swapan Dutta of Rengkai Edenthur, Churachandpur. During the search, one INSAS Rifle bearing Regd. No. 18273010 along with four magazines containing 36 rounds of 5.56 mm live ammunition were found concealed beneath the mattress of the accused. Further, one camouflage bulletproof vest was also recovered during the search of the room. The said arms and ammunition, bulletproof vest, and one iPhone 7 (pink colour) bearing mobile No. 6909214375 belonging to the accused were seized under proper seizure memo at about 8:30 PM.






