(31 January 2026, around 7:00 AM) near Ema Keithel (bridge pillar)

Respected Sir/Madam,

I, MD NAQUIBUL GHAUS, student of Manipur University, permanent resident of Delhi and currently residing at Manipur University Hostel (Hostel 6, Chinga), humbly request you to kindly register my complaint and lodge an FIR regarding the theft of my Honda Dio scooter bearing registration number MNO1 AF 3603 (RC owner: BASIRA BEGUM). The theft occurred on 31 January 2026 at around 7:00 AM near Ema Keithel (Ima Keithel), MG Avenue, near the bridge pillar.

On the above date and time, I parked my Honda Dio near the bridge pillar in front of Ema Keithel to purchase vegetables. I was away for hardly 5 minutes, and when I returned, my scooter was missing. Shockingly, another scooter was parked at the exact same spot where my scooter was parked earlier. I waited there for around 30 minutes and also took help from nearby police personnel, but my scooter could not be traced. No one came to claim the other scooter, which makes it strongly suspicious that the person who parked that scooter there stole my Honda Dio.

The scooter left at the spot has registration number MN01Y0289, and I have attached clear photographs of the vehicle and number plate. I request you to kindly register an FIR, verify the details of the suspected scooter, check nearby CCTV footage, and take immediate necessary steps to recover my stolen scooter and identify/arrest the offender. I will cooperate fully in the investigation.


