Sir,

I have the honour to report that today i.e. 5/5/2026, I along with my wife went to the District Hospital, Thoubal on one scooter Honda Activa red in colour bearing regn. no. **MN04D8853**, chassis no. ME4JF50AGJT316615 and engine no. JF50ET7316590 which is recorded in the name of my uncle Shoibam Kiran Singh s/o late Sh. Iboyaima Singh of Thoubal Achouba Makha Leikai and arrived hospital at about 2:30 pm. We went together by foot to the Gyneacology ward after the said vehicle was parked in front of Gyneacology block with proper lock. When we went out of the Gynae ward at about 2:40 pm, the said vehicle was found missing at the parked area. We have searched around the area but it vain. Lateron, I came to know that the said vehicle was stolen away by unknown person. Registration certificate (smart card) of the said vehicle was put inside its toolbox. The approximate value of the stolen vehicle would be Rs. 60,000.
