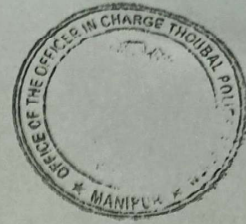

That, without any further delay, I along with my other relatives have visited my house and upon entering, all the household items/materials were found scattered all over the room which include one electric inverter were damaged/broken.

That, on further checking of the items/materials, the following were found missing which was suspected to have been committed by some unknown persons after the backside door was broken.

It is therefore requested to kindly inquire into the matter to find the culprit if possible.
