Sir,



I, the Complainant abovenamed would like to place the following few lines for kind perusal and prompt appropriate legal actions :-

1. That, I am the owner of the paddy land covered by Old patta No.133 corresponding to New patta No.504 covered by C.S dag No.4354 having an area of 1.0900 hectare (2.6934 acres) of Village No.133 Wangjing(for short the paddy land) It may be stated that the Ld. Civil Judge, Jr. Div. Thoubal was also pleased to pass an ex-parte ad interim injunction order dated 19.09.2022 in Judl Misc Case No.211 of 2022(arising out of O.S No.29 of 2022) land from the peaceful possession of the applicant and the said order was made absolute by the Ld. Civil Judge Jr.Div, Thoubal on 18.10.2022. The abovenamed accused persons however in defiance of the said order of the Court has entered into the paddy land and harvested the paddy crops grown by me for which I filed the Judl.Misc Case No.247 of 2022 in the court of Civil Judge Jr. Div. Thoubal for disobedience and the same is pending. It is pertinent to mention herein that an FIR being No.126(7)2022 TBL-PS U/s 447/430/427/506/34 IPC is also registered and under investigation against the abovementioned accused persons.
2. That, accused persons abovenamed again and again repeatedly disobeyed the order of the Hon'ble Court dated 18.10.2022 passed in Judl.Misc Case No.211 of 2022 ,the accused persons criminally trespassing the suit land and kept on interfering with the peaceful possession of the suit land by me and performed means illegal activities where he is prevented by the Hon'ble Court order dated 18.10.2022. The accused persons has also no right and authority to enter to the suit land

3. That, the Complainant also filed Judl Misc Case No.426 of 2025 before the Ld. Civil Judge Junior Division, Thoubal for giving direction to the Police i.e Superintendent of Police, Thoubal District and Officer in Charge, Thoubal Police station within whose jurisdiction the suit land is situated to implement the order of the Hon'ble Court dated 19.09.2022 passed in Judl Misc Case 211 of 23022 which was made absolute on 18.10.2022 as the accused in defiance of the Court's order harvested the crops and the same is pending now in the Hon'ble Court.



4. That on 18.05.2026 at about 8.30 am, I went to my paddy field for ploughing the land for the purpose of starting cultivation work of the paddy field for the current year 2026. When I and my hired Tractor driver namely R.K Khembao of Wangjing Awang Leikai started ploughing the paddy field about 30 minutes in, the accused person abovenamed forcefully enter to the paddy field armed with deadly weapons such as stick, Louri Thangjou, Spade with the common intention to assault me and started attacking and assaulting me with the said weapons and the accused persons pulled me and asked me to leave the paddy field immediately otherwise I will face dire consequences and even I would be killed if I remained in my paddy field. In the manner I was assaulted by the accused persons armed with such deadly weapons I would lost my life if I remained therein. Having no option in order to save my life I came back home.
5. That, I have a real apprehension that the accused persons would commit such illegal acts again and there is sense of fear to me by such illegal acts of the accused persons which they shall commit anytime where I continue cultivation work in the paddy field (suit Land). I am therefore filing the present complaint to your Goodself for taking necessary legal actions against the accused

person by registering regular FIR and punish them according to law..

I therefore, pray to your Goodself to kindly register a regular FIR case against the accused persons abovenamed and punish them according to law for the ends of justice.
