Today i.e. 08/05/2026 at 07.10 pm received a reliable information that on the same day at around 07.05 pm, one Bolero, Grey in colour, bearing registration No. MN01G-1665, plying from Kakching side towards Khongjom side, driven by an unknown driver collided with one Honda Dio, black in colour, bearing registration no. MN04G-9644, ridden by an unknown rider plying from khongjom side towards Sora side near Slopeland Public School, Khongjom along NH-102. As a result of which the unknown rider of Honda Dio sustained serious injuries on his person and evacuated to JIVAN Hospital, Kakching, for medical treatment and declared brought dead by the concerned doctor. The vehicles, Bolero, Grey in colour, bearing registration No. MN01G-1665 was partially damaged but the Honda Dio, black in colour bearing registration no. MN04G-9644 was badly damaged.

Hence a regular suo-motu case under FIR No. 13(05)2026 KJM PS U/S 281/125(b)/324(4)/106(1) BNS 2023 has been registered for investigation.

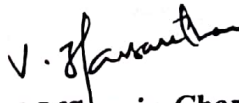
