Today i.e. 17/05/2026 at 02.55 pm received a reliable information that on the same day at around 02.48 pm, one Tata 407, red in colour, bearing registration No. Nil, plying from Sora side towards Khongjom side, driven by an unknown driver hit 4 (four) pedestrian including 2(two) baby boy and 2(two) women near Slopeland Public School along NH-102. As a result of which the unknown four pedestrian sustained serious injuries on their persons and were immediately evacuated to District Hospital Thoubal, for medical treatment. During the treatment the attending doctor declared one baby boy brought dead, while the remaining others were referred to higher hospital for further treatment.

Hence a regular suo-motu case under FIR No. 15(05)2026 KJM PS U/S 281/125(b)/106(1) BNS 2023 has been registered for investigation.
