Sir,

With due regards, I beg to state that today i.e. 22/05/2026 at about 03:30 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Tekcham Maning Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, MPS, Addl. SP (Ops) Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 46 AR have rushed to the spot immediately and launched a massive operation at 04:50 a.m. On searching and found the undernoted articles from the spot and seized at 05:27 a.m. by observing formalities.

- 1 (one) No. of SMG Carbine along with magazine,
- 4 (four) Nos. of Bolt Action Rifles,
- 2 (two) Nos. of 9 mm Pistol along with magazine,
- 1 (one) No. of SBBL bearing No. 25368-2004,
- 1 (one) No. of DBBL marked as 'Green & Co',
- 4 (four) Nos. of 2 inch Para Bomb,
- 1 (one) No. of 36 HE Hand Grenade,
- 10 (ten) Nos. of 12 Bolt cartridge and
- 3 (three) Nos. of 9 mm live rounds.

The massive searched Operation was conducted from 04:50 a.m. to 06:00 a.m. on the same day.
So, it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
