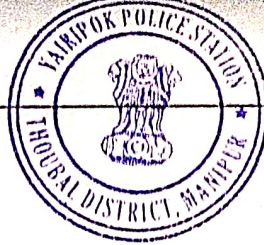

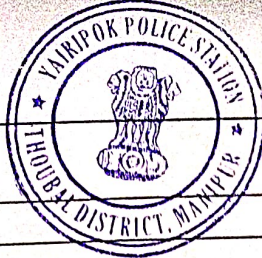

11. First Information contents:

Today i.e. on 21/04/2026, at around 08:30 pm, a torch rally was organised by Yairipok Apunba Meira Paibis and local clubs in support of the 05 (five) days state wide shut down called by All Manipur Meira Paibies in c/w the recently killing of two children and injured mother by the bomb blast that took place at Tronglaobi, Bishnupur.

Around 1500 persons, mainly women folk and youths came from different areas of Yairipok and gathered at the Yairipok Bazar.

At around 09:30 pm the rally was concluded peacefully and most of the women folk and youth dispersed right after. After the conclusion of the rally, when most of the people dispersed, some random youth proceeded towards Yairipok-PS. The intention youth was malified as they started pelting stones, marbles, ball bearing using catapult despite call for appeasement and appeals to disperse they continue storming towards PS.

As a result, one police Commando namely Mungam Keishing aged about 37 years. S/o Solomon Keishing of 4th IRB Rfl. No. 419 [REDACTED] attached to CDO Unit Thoubal, sustained injuries just above the right eyebrow and on the left knee. Window glasses of the office premises were also damaged.

As the violence escalated, the police personnel of Yairipok PS, CDOs and 171 Bn. B-Coy BSF had to take up necessary action to prevent injury to person and damage to property. Hence, minimum force was utilised, firing of the tear smoke shells was done to disperse the ruffian's thus assembled.

In the process two asailants namely 1. Khumanthem Dinesh Singh (27) yrs s/o Kh. Beikun Singh of Yairipok Yambem Makha Leikai, Imphal East District. 2. Laikhuram Tangba Meitei (22) yrs. S/o. Laikhuram Irabanta of Yairipok Laimanai, Imphal East District were arrested from Yairipok Bazar near bridge at 11:35 pm by a team of Police. On their body search found 02(two) mobile phones along the seizure of marbles from their possession at 11:45 pm respectively.

Necessary formalities could not be observed at the spot due to sensitive nature of the circumstances.

Hence, a suo motto case under FIR No. 20(04)2026 YPK-PS u/s 189/191/191(3)/324/132/133/223 BNS, 2023 is registered at Yairipok PS for further investigation.
