Today, i.e., 29/04/2026 at 7:30 pm received an information that on the same day at around 07:25 pm, one TVS NTORQ-125 (black and red in colour) bearing Regn. No. MN06SG-7838, ridden by an unknown rider While proceeding from Yairipok Bazar towards Yairipok Bishnunaha side was dash by one Honda Activa (dark blue in colour) bearing Regn. No. MN04G-8317 ridden by unknown rider, which was proceeding in the same direction at Yairipok Bishnunaha near Chongtham Leirak along Yairipok Thoubal road due to rash or negligent driving on the part of Honda Activa rider. As a result of which both the unknown riders received serious injuries on their persons and evacuated to hospital for medical treatment. Both the vehicle were also party damaged.

Hence a suo motu case under FIR No. 21(04)2026 YPK- PS u/s 281/125(b)/324(4) BNS, 2023 has been registered for investigation.
