Sir,

With due regards, I beg to state that today i.e. 05/05/2026 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foot hill of Chakama Hill Range for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, MPS, Addl. SP (Ops) Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 31 AR have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found the undernoted articles from the spot and seized at 05:11 a.m. by observing formalities.

Details of seized articles :

1. 1 (one) No. of Stun Gun,
2. 1(one) no. of DBBL mark as BSA CORP,
3. 1(one) no. of SBBL,
4. 1(one) no. of Pistol along with magazine,

The massive searched Operation was conducted from 04:30 a.m. to 06:30 a.m. on the same day.
