I, the undersigned have the honour to state that, on 20/05/2026 at about 03:00 pm my Honda Activa Honda Activa DLX 0BD2B PS Blue in colour, bearing registration no. MN06SX9965, Chassis no. ME4JK362DTD106965, Engine no. JK36ED2106993 which was parked at Charangpat Mamang Leikai near Brick Field was found stolen by the unknown miscreant(s).
