Abdullah aged about 55 yrs S/o. Late Md. Abdul Samad, (2) Md. Wakib aged about 34 yrs S/o. Md. Abdullah, (3) Md. Sajid aged about 24 yrs S/o. Md. Abdullah, (4) Mrs. Thaballei aged about 47 yrs W/o. Md. Abdullah all are resident of Kiyamgei Mayai Leikai and (5) Md. Rahish aged about 26 yrs S/o. Md. Rafijuddin of Keirao entered into my house forcibly and threatened me and my family members. Thereafter the above mentioned persons set on fire my house by using gas torch lighter without giving any known reason. They even assaulted my one son namely Suheb aged about 16 yrs and received injury on his forehead. The above mentioned individuals immediately fled away from my house. The nearby persons rushed

to our house and extinguished the fire. As a result of which, some properties and some important documents i.e. 1 (One) Bed, mattress, Mosquito net, bed sheet, wearing clothes, School Certificates etc. were completely burned into ashes.
