Subject: Report

Respected Sir,

I, Mm. Hamida, 28 yrs W/o Md. Wakib a resident of Kiyamgei Mayai Leikai most respectfully beg to state the following facts for your kind consideration and necessary legal action:

1. That the accused person namely Md Abdullah @ Abdur Rahaman, son of Late Abdul, resident of Lilong Atoukhong, Thoubal District, Manipur - 795130, is our close relative. His wife Dilorjan is the younger sister of my mother. The said Md. Abdullah @ Abdur Rahaman is presently employed as a Security Guard at Bank of Baroda, Saikhul Pangei Road Branch, Manipur.

2. That in the year 2017, my father in law had opened a bank account in the aforesaid bank with the intention of applying for a loan. However, the loan was never sanctioned by the bank authorities, and thereafter we completely stopped pursuing the said loan application.

3. That after a few months, my maternal grandfather Late Mohd. Abdur Rashid requested my father in law to stand as a guarantor for a loan account bearing No. 83450600000347 in the said bank. Trusting the family relationship and in good faith, my father in law agreed to become only a guarantor and accordingly signed certain documents as required by the bank.

4. That after approximately two years, we suddenly received notices and documents from the bank demanding payment of an amount of Rs. 5,74,514/- (Rupees Five Lakhs Seventy-Four Thousand Five Hundred Fourteen) along with unapplied interest. To our utter shock and surprise, the documents reflected my father not as a guarantor but as the principal loanee/borrower.

5. That thereafter, we visited the concerned branch of the bank on several occasions and sought clarification regarding the said irregularities and discrepancies. However, the bank officials failed to provide any satisfactory or positive response regarding how my father's in law status had been converted from guarantor to loanee.

6. That subsequently, we approached the accused Md. Abdullah @ Abdur Rahaman at his residence and discussed the matter peacefully. During the said discussion, he assured us that he would settle and repay the loan amount and requested us to cooperate and favour him considering the family relationship.

7. That after the said assurance, the accused paid certain instalments for a few months but thereafter intentionally stopped making payments. Consequently, due to continued pressure and notices from the bank, we again visited his residence in order to request him to resolve the issue amicably.

8. That on 22/05/2026 at around 8:50 pm, five of our family members (Md. Abdullah age-52, Thaballei age-50, Wakip age-29, Rahees age-25, and Sajid age-20) went to the residence of Md. Abdullah @ Abdur Rahaman and called him from outside his house requesting him to come out and discuss the matter peacefully. After some time, he came out along with his family members and instead of discussing the matter peacefully; he suddenly started shouting loudly and falsely alleging before the neighbours that we had come to kill him.

9. That thereafter, the accused instigated the neighbouring persons and called for hockey sticks and other weapons. In the meantime, the accused Md. Abdullah @ Abdur Rahaman violently attacked our vehicle and intentionally damaged the same.

10. That thereafter, Md. Abdullah @ Abdur Rahaman and his wife namely Dilorjan called upon their children namely Lily, Sima, Abdul Rajak, Ferojan, Rubani and Suhail along with two unknown persons who collectively and aggressively advanced towards our family members with the intention to assault and physically attack.

11. That the accused persons had assaulted my 5(Five) family members in a violent manner with dire consequences. Due to the intervention of neighbouring persons who advised to leave the place to avoid further violence, my family members somehow escaped from the spot and saved themselves from grievous injuries and possible fatal consequences.

12. That as Md. Abdullah @ Abdur Rahaman is our relative and while our elders were trying to have a sitting with Md. Abdullah @ Abdur Rahaman & his family members to bring an amicable settlement regarding the incident, we didn't file any complaint to any law Court/Police Station regarding the incident.

13. That to our utter surprise, notice to my above mentioned 5 (Five) family members has been received from Lilong Police Station directing them to appear before the Police Station as if they are the accused persons in the matter.

14. That the accused persons are trying to misuse their influence and are attempting to falsely implicate my family members in fabricated allegations in order to escape from their liabilities and unlawful acts. The conduct of the accused persons clearly amounts to offences punishable under the relevant provisions of the Bharatiya Nyaya Sanhita (BNS), including criminal intimidation, unlawful assembly, assault, mischief causing damage to property and conspiracy.

15. That the present complaint is being submitted seeking fair investigation and protection of my family members lives, liberty, and property from the unlawful acts and threats of the accused persons and their associates.

In view of the facts and circumstances stated above, it is therefore most humbly prayed that your good office may kindly:

- a) Register a proper complaint/FIR against Md. Abdullah @ Abdur Rahaman, his wife Dilorjan, their children namely Lily, Sima, Abdul Rajak, and the two unknown persons involved in the incident;
- b) Conduct a fair and impartial investigation into the entire matter;
- c) Take strict legal action against the accused persons in accordance with law;
- d) Provide necessary protection to our family members from further threats, intimidation, and possible physical harm.
