Sir,

I, Ashok Shah, would like to lodge a complaint regarding an incident of robbery that took place at our petrol pump on 21 May 2026 at around 3:00 PM.

The accused came to the petrol pump with a knife and started threatening the staff present at the premises. He demanded money from the staff members and created fear and panic among them.

During the incident, the accused physically assaulted one of the staff members and forcibly snatched cash amounting to approximately Rs. 50,000/- from the petrol pump.

The accused fled from the spot immediately after committing the offence. The staff members are frightened due to the incident.

I request you to kindly register the complaint and take immediate necessary action to investigate the matter, identify the accused person, and recover the looted cash. Necessary protection and security measures may also kindly be provided.
