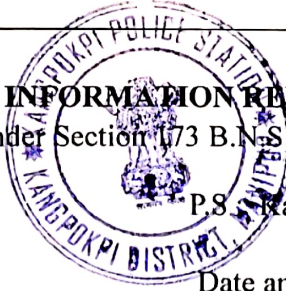

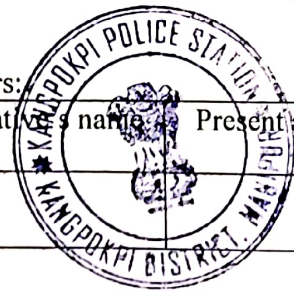

The brief fact of the case is that based on specific intelligence input, regarding the presence of weapon cache hidden by unknown armed miscreants in the general area of Maohing village about 7.5 kms North-West of Kangpokpi Police Station, Kangpokpi District. On receipt of the input, a combined search operation (CASO) comprising Kangpokpi Police led by Shri. Pavitra Goyal, IPS(P), OC/KPI-PS accompanied by QRT of KPI-PS led by ASI L. Lunminthang Haokip, 2(two) teams of 16 AR led by Asst. Commandant Vivek Kumar Singh and a platoon of A/112, QAT & BDDS Teams of 112 Bn. CRPF led by Sh. Manoj Kumar, Deputy Commandant under the overall supervision of SP/KPI launched an operation in the said areas on the 6th April, 2026 from 0405 hrs to 0830 hrs . During the search, the unknown armed miscreants were not found in the general areas, suspected to be fleeing away from the scene by taking advantages of the thick jungle. However, the following arms & ammunitions were recovered after a long conduct of the search.
