Sub: Complaint Report

Sir,

I have the honour to report that on 03/05/2026 at about 02:00 a.m., a reliable information was received regarding the presence of a suspected member of a banned organization, namely KCP (Ibungo Ngangomba faction), at Kakching Khunou Lamkhai area.

On receipt of the said information, a combined team of CDO Unit Kakching, under the command of Sub S. Birla Singh, OC CDO Unit Kakching, and under the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching, immediately proceeded to the said area for verification of the input.

Upon reaching the spot, the combined team conducted cordon and search operations along with frisking and checking in the area. During the course of such checking, one individual moving in a suspicious manner and matching the input description was intercepted and detained at Kakching Khunou area along with one Hyundai i20 asta (white in colour) bearing Registration No. MN01AX-9290.

At the time of interception, which occurred during late night hours, the identity and specific involvement of the individual could not be ascertained with certainty at the spot and the situation required cautious handling. Accordingly, the individual was detained and brought to the CDO Unit for proper verification and lawful inquiry. In view of the time and field conditions, detailed procedural formalities including documentation and videography were carried out at the Unit after ensuring safety and proper identification of the individual.

During the course of such verification and questioning, the individual disclosed his identity as Laishram Anil @ Chara Singh (34) years, S/o Laishram Bino Singh of Changangei Mayai Leikai, Imphal West District, Manipur. During further inquiry, he disclosed that he is an active member of the banned organization KCP (Ngangomba faction), having joined the said organization in the year 2024 through one Poribion @ Thouba and working under his command. He further disclosed his involvement in unlawful activities, including threatening and coercing cargo carriers of certain airlines to stop transportation of specific goods, particularly betel leaf consignments, in furtherance of the demands of the said organization.

From his conduct, disclosure, and the surrounding circumstances, sufficient prima facie materials indicating his involvement in unlawful activities were established. Accordingly, he was formally arrested at about 04:00 a.m. on 03/05/2026 after observing necessary legal formalities. From his production recovered on One Plus 13R Mobile phone bearing IMEI1-867795070415499 & IMEI2-867795070415481 along with Airtel SIM No.9233591831 and the said vehicle i.e. Hyundai

i20 asta (white in colour) bearing Registration No. MN01AX-9290 was seized at about 04:05 a.m. in connection with the case.

The arrested person along with relevant documents and seizure items i.e. (1) One Plus 13R Mobile phone bearing IMEI1-867795070415499 & IMEI2-867795070415481 along with Airtel SIM No.9233591831 and (2) Hyundai i20 asta (white in colour) bearing Registration No. MN01AX-9290 is handed over to OC, Waikhong Police Station for taking further necessary legal action as per law.
