On receipt of the said input, combined teams of CDO Unit Kakching comprising Kilo-31, Kilo-77 and Kilo-93, along with a column of 46 AR, under the command of Sub. S. Birla Singh, OC/CDO Kakching, and under the supervision of Shri. Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and overall supervision of Smt.
