Sir,

I, the undersigned, have the honour to state the following facts for your prompt action in the matter.

I am the owner of the homestead recorded under Patta No. 62(old) corresponding to New Patta No. 58, covered by C.S. Dag No. 1391/Part of village No. 52.

My elder brother namely, Khuraijam Ratankumar Singh, without my consent, started construction of a Pucca latrine in my said homestead in that I repeatedly told him to stop the construction of the Pucca latrine, however, he paid no heed and continued the construction of the latrine.

On 21/10/2025, I reported the matter to your goodself and later my said elder brother attended the police station and in that a settlement was arrived before your goodself to the effect that the construction of said latrine shall be stopped during the pendency of the case in the court relating to the said homestead land.

On 06/05/2026 at about 12:30 pm, my brother, besides the settlement already arrived, again started constructions of the latrine construction labourers and in that I told my brother to stop the construction and tried to capture photographs to prove the new construction, however, my said brother started beating me by a wooden log (cheitup) and also thrown breaks towards me with an attempt to kill me in an around 11:40 am to 12:20 pm. On seeing the scene, my wife Mutum Premita Devi tried to save me from such attacks of my elder brother, in that, both I and my wife were injured. By such attacks of my elder brother, my left leg got fractured and my right shoulder was also injured. My wife was also injured on her hand and head. On seeing the scene, the localities came and save me and my wife from such attacks of my elder brother and thereafter, I and my wife rushed for medical treatment.

It is humbly stated that the act of my elder brother is attempt of my life as if he is above the law of this country.

Your goodself is therefore, requested to take prompt action against my said elder brother, Khuraijam Ratankumar Singh for committing such offences.
