Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 33 AR immediately rushed to Wabagai Bazar near Bus parking at around 1:30 p.m. and conducted frisking and checking of suspected persons. In that one TOYOTA Innova car Silver Mica Metallic in colour bearing registration No. MN05A 6200 was coming from Wabagai Side towards Kakching side in a suspicious manner. On their suspicious nature, they were detained for verification.

On preliminary verification they were identified themselves as (1) the driver, Salam Dhananjoy Singh @Amuba (49) yrs. s/o. Late S. Isheihanba Singh of Hiyanglam Awang Leikai, Kakching District and (2) S/S Major Keisham Prabin Meitei @Sagar (46) yrs. s/o. Late K. Achouba Meitei of Patsoi Part-I, Imphal West, District they are a banned outlawed PREPAK (Pro) organisation.

On their bodies search found (i) 2(two) mobile handset i.e (a) itel Keypad mobile handset with one Airtel SIM card bearing mobile number 7085639277 and (b) SAMSUNG Galaxy M30s mobile handset with one Airtel SIM card bearing mobile number 8732857943 the possession of Salam Dhananjoy Singh @Amuba (49) yrs. and (ii) one Redmi 13 5G mobile handset with one Airtel SIM Card bearing mobile number 8131898224 from the possession of S/S Major Keisham Prabin Meitei @Sagar (46) yrs.

On verification of (1) Salam Dhananjoy Singh @Amuba (49) yrs. disclosed that he joined PREPAK(PRO) in the year, 2023. He stated that he was arrested by CDO/KCG in the year, 2024 and he was released on bail in the year, 2024. Again he re-joined PREPAK(PRO) through Mr. Irei of PREPAK(PRO). He is presently working under the command of Finance Secy. Mr. Irei of their organisation.

On verification of (2) S/S Major Keisham Prabin Meitei @Sagar (46) yrs. disclosed that he joined PREPAK(PRO) in the year, 1999 through Mr. Nganthoi of their organisation. He got 45 days basic military training at Tubung, Pherzawl under army number 722 of 7<sup>th</sup> Batch. He stated that he was arrested by CDO/TBL in the year 2016 and he was released on bail. Again he re-join PREPAK(PRO) in the year, 2023. He is providing logistic support to his organisation.

Hence, they were arrested at 2:00 p.m. and 2:02 p.m. respectively of 10/05/2026 from Wabagai Bazar near Bus parking by observing formalities and seized the above mentioned articles i.e. (1) 2(two) mobile handset i.e (a) itel Keypad mobile handset with one Airtel SIM card bearing mobile number 7085639277 (ii) SAMSUNG Galaxy M30s mobile handset with one Airtel SIM card bearing mobile number 8732857943 and (iii) one TOYOTA Innova car Silver Mica Metallic in colour bearing registration No. MN05A 6200 from the possession of Salam Dhananjoy Singh @Amuba (49) yrs. and (2) one Redmi 13 5G mobile handset with one Airtel SIM Card bearing mobile number 8131898224 from the possession of S/S Major Keisham Prabin Meitei @Sagar (46) yrs. at 4:20 p.m. and 4:23 p.m. respectively of the same day at DHQ, Thoubal by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography could not be done at the spot as an information was received from intelligence sources that some organised public mob may be initiated to forcefully free the arrested accused person. Hence, all the documentation works were prepared at DHQ, Thoubal at about 4:30 p.m. of the same day and recorded through e-Sakshya portal.

The arrested persons mentioned above along with seized articles are handed over to you for taking further necessary legal action against them.


