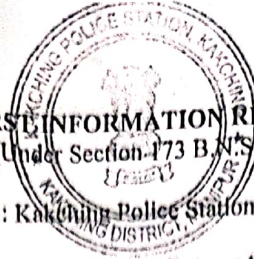

With due respect, I have the honour to report that on 05/05/2026 at about 8:00 a.m., based on credible intelligence received from a reliable source regarding the transportation of fuel (suspected petroleum/diesel) without a valid permit from Thoubal side towards Pallel, a naka/check post was alerted and conducted random Frisking & Checking at Kakching Lamkhai.

During the frisking & checking one Eeco Van bearing registration No. MN01AG-9550 (silky silver in colour) was detained at about 9:30 a.m. Upon inspection, it was found that the vehicles were carrying a large quantity of suspected petroleum stored in plastic containers/drums without proper safety measures and without producing any valid permit, licence, transit documents, or authorization for transporting such hazardous and inflammable substances. The drivers identified as Md Rohid (23) yrs. S/o. Md Allauddin of Lilong Leihaokhong, Thoubal District and the occupant as Md. Islao Rahaman (25) yrs S/o. (L) Md.
