Kumar Meitei received a reliable input from 165 TA, 5 AR and 11 wireless by SAFE/TBL(special action force for extortion) that some active members of PREPAK(PRO), a banned unlawful organisation are loitering in and around Salungpham area with an intention to carry out illegal activities. Acting on the information, organised a joint team of CDO Unit TBL led by Insp. K. Nitaranjan Singh, OC CDO Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. SP(Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal District and a column of 31 AR immediately rushed to Salungpham Kang Thokchao, Maning Leikai area at around 04:35 p.m. and conducted frisking and checking of suspected persons. In that, one unknown person was seen in a very</p>			

			<p>suspicious manner. On suspicion, the unknown person was detained for verification. On preliminary verification he identified as S/S Captain Laishram Bimol Singh @ Bhai (40) yrs. S/o. Late L. Acting on the information, a joint team of Commando Unit Thoubal led by Insp. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal immediately rushed to Yairipok Angtha near Thambalnu Market at around 03:55 a.m. after giving necessary information to Imphal East Control Room and conducted frisking and checking of suspected persons. In that, one unknown person was seen in a very suspicious manner. On suspicious nature, he was detained for verification. On preliminary verification, the unknown person identified himself as Phanjoubam Rabi Meitei @ Luwangamba aged about 28 yrs. s/o. Ph. Kula Meitei of Andro Lapaochum Tampak Leikai Imphal East District, s/s Private of banned RPF/PLA unlawful organisation. On his body searched found one Redmi 14C mobile phone along with 1 (one) Airtel SIM cards bearing mobile No. 9612330203 from his possession. On further verification, he disclosed that he join RPF/PLA in the year 2016 through one Lemba of their organisation. He got 6(six) months basic military training at 252 Mobile Battalion Training Centre, Myanmar under Army No. 3305. He also disclosed that he is working under the command of s/s Colonel Rishikanta of their organisation. He further disclosed that he had kept concealed some TNT at the clump (Wapal) of one Chingakhm Gopal which was delivered by s/s Colonel Rishikanta to him and instructed him to carry out a blast as a threat to the businessmen and shopkeepers of Allu Gali at Thangal Bazar. He further disclosed that he had also delivered 3 (three) Nos. of TNT to his 2 (two) of his associates namely:-i) Md. Ruwaj Arif and ii) Inaocha of Kiyamgei under the instruction of s/s Colonel Rishikanta</p>			

			<p>of RPF/PLA. Hence, he was arrested at 04:10 a.m. from Yairipok Angtha near Thambalnu Market by observing formalities. Accordingly, the above mentioned joint team along with CDO/IE and a column of 33 AR immediately rushed to the said area i.e. clump (Wapal) of Chingakham Gopal. On his pointing found a black polythene buried at the clump (Wapal) of Chingakham Gopal, on opening the black polythene and found containing- i) 2(two) Nos. of timer, ii) 2(two) Nos. of detonator, iii) 4(four) Nos. of TNT weighing 200 grams each and iv) one Nos. of TNT weighing 1.133 kg.Hence, the above mentioned articles i.e. i) 2(two) Nos. of timer, ii) 2(two) Nos. of detonator and iii) 5(five) Nos. of IEDs and iv) 1(one) Redmi 14C mobile phone along with 1 (one) Airtel SIM cards bearing mobile No. 9612330203 were seized at 04:57 p.m. of the same day at DHQ Thoubal from his possession by observing formalities.Further, the Joint team immediately rushed to Kiyamgei as pointed by Phanjoubam Rabi Meitei @ Luwangamba, Md. Ruwaj Arif was detained for verification. On preliminary verification of Md. Ruwaj Arif, he identified himself as Md. Ruwaj Arif @ Babool aged about 23 yrs. s/o. (L) Md. Rahaman of Kiyamgei Makha Leikai, Imphal East District an active member of RPF/PLA. On his body searched found one Oppo A5x 5G along with one Jio SIM card bearing mobile No. 6009879959 from his possession. He further disclosed that he and handed i) 2(two) Nos. of TNT and ii) 1(one) No. of IED to his associate namely Inaocha of RPF/PLA. Hence, Md. Ruwaj Arif @ Babool aged about 23 yrs. s/o. (L) Md. Rahaman of Kiyamgei Makha Leikai, Imphal East District was arrested at 10:00 a.m. of 26/03/2026 from Kiyamgei near his house and seized the above mentioned Oppo A5x 5G along with one Jio SIM card bearing mobile No. 6009879959 from his possession at 04:59 p.m. of 26/03/2026 at DHQ Thoubal by observing formalities.Further he disclosed that his associate namely Inaocha was staying at Leiphrahpam Awang Leikai. Joint team immediately rushed to the said area. On pointing of Md. RuwajArif @ Babool, Inaocha was detained for verification. On preliminary verification of Inaocha, he identified himself as Md. Abdul Hakim @ Inaocha aged about 35 yrs. s/o. Md. Abdul Khaliq of Kiyamgei Mayai Leikai Imphal East District, an active member of RPF/PLA. On his body searched found one Infinix SMART 9 along with 2(two) SIM cards i.e. Jio SIM cards bearing mobile No. 6009900864 and BSNL SIM card bearing mobile No. 8014375541from his possession.He further disclosed that he had kept concealed handed i) 2(two) Nos. of TNT weighing 200 grams and ii) 1(one) No. of TNT weighing 536 grams which was handed to him by Md. Ruwaj Arif @ Babool. On pointing of Md. Abdul Hakim @ Inaocha found 3(three) no. of IEDs which were recovered from the foot of a banana plant at the river bank of Imphal River near his house, which were kept concealed by him. Hence he was arrested at 04:10 p.m. of 26/03/2026 from Leiphrahpam Awang Leikai near Imphal River by observing formalities. And seized the above mentioned Infinix SMART 9 along with 2(two) SIM cards i.e. i) Jio SIM card bearing mobile No. 6009900864 and BSNL SIM card bearing mobile No. 8014375541, ii) 2(two) Nos. of TNT weighing 200 grams each and iii) 1(one) No. of TNT weighing 536 grams from his possession at 05:01 p.m. at DHQ Thoubal by observing formalities.</p>
