Subject: Report.

Sir,

I have the honour to state that, today i.e., 05/04/2026 at about 1.30 pm, when I was at NAB-PS, Manipur one of my source man informed me that, 2 (two) persons namely 1) Ankit of Bihar and 2) Aman of Bihar were carrying a huge quantity of brown sugar which will be going to left Imphal through winger from North AOC to Bihar. The said information was reduced in writing and placed before the Superintendent of Police/NAB, Manipur. Then, I along with a team of NAB-PS, Manipur and all the necessary equipment were constituted for execution of the secret information.

A team of NAB-PS, Manipur moved towards North AOC area of Imphal West District, Manipur in the departmental vehicle Maruti Gypsy bearing No. MN01G 0361 along with necessary equipment and documents for looking the same two persons. On reaching the said spot and indicated by the source man, the team of NAB-PS, Manipur found two persons in suspicious manner carrying a black bag on the road side of North AOC opposite to Imphal Hotel by Classic, Imphal West District, Manipur. Accordingly, after identifying ourselves as the police officer and personnel of NAB-PS, Manipur they were stop at the spot for checking. On asking, they told the police team that, they are carrying brown sugar inside the black bag and they were detained at the spot for verification and checking.

I requested nearby civilian to witness the search, seizure and arrest procedure and only one civilian namely Laishram Dirosan Meitei 32 yrs s/o L. Dinesh of Thangmeiband Lourungpural Leikai, IW District, Manipur agreed to witness the same. Simultaneously, one personnel from my team namely C/No. 0901358 Abujam Bikramjit Singh 40 yrs s/o (L) A. Tikendrajit Singh of Samurou Awang Leikai, IW District, Manipur voluntarily agreed to witness the same. At the meantime, a requisition was submitted to Scientific Officer, Mobile Forensic Unit, Lamphel, Imphal West for deputing a team of Mobile Forensic Unit. As requisite, the team of MFU, IW District led by Ningombam Sashibala Devi, Scientific Assistant were reached at the spot.

In presence of the witness, the detainee were identified themselves as 1) **Ankit Rai 22 yrs s/o Raj Narayan Ray of Chhotka Dhakaich, PO-Barcka Dhakaich, District- Buxar, Bihar – 802133 a/p Hatta Golapati** and 2) **Aman Kumar 21 yrs s/o Suresh Das of Joriyahi, District – Sitamardi, Bihar 843313 a/p Paona Bazar Hero Cycle**. Further, I briefed about the provisions of section 50 NDPS Act, 1985 in hindi language to the detainee and were informed that they have legal right u/s 50 NDPS Act to be searched their belongings before Magistrate/Gazetted Officer or Civil/Independent Witnesses, if they so desire. A notice u/s 50 NDPS Act each was served to them in which they opted to be searched before civil witnesses.

Further, in presence of the witness, the team of MFU, IW District, Manipur started conducting legal procedures. The MFU, IW District, Manipur marked **the black bag labelled "ALAN WALKER" as "A" for identification**. On opening the bag marked as "A", found a black polythene packet wrapped with a small piece of cloth violet and grey colour. On opening

the black polythene packet, again found another black polythene packet. On further opening, found a **transparent polythene packet containing brownish like substance suspected to be brown sugar and marked "B" for identification**. The MFU team opened the packet marked as "B" and took a pinch of suspected brown sugar for field testing by using field testing kits brought by them. **The test gave positive response of Brown Sugar**. After taking out a negligible amount of brown sugar from the packet marked "B" for sample by the team of MFU, weighing was conducted and found 312 gram and put in a **yellow paper envelope which was properly packed and sealed with wax and marked the same "B" as parent exhibit**.

In presence of the witnesses, one yellow paper envelope which was properly packed and sealed with wax marked as "B" containing 312 grams of brown sugar, one black bag labelled "ALAN WALKER" marked as "A", one small piece of cloth violet & grey colour and 2 (two) black colour polythene were seized from the possession of **1) Ankit Rai 22 yrs s/o Raj Narayan Ray of Chhotka Dhakaich, PO-Barcka Dhakaich, District- Buxar, Bihar – 802133 a/p Hatta Golapati and 2) Aman Kumar 21 yrs s/o Suresh Das of Joriyahi, District – Sitamardi, Bihar 843313 a/p Paona Bazar Hero Cycle at the spot on the same day at 3.00 pm by preparing a weighing and seizure memo.**

Further, 1) one mobile phone Realme C73 5G having mobile No. 9117835459, 2) one mobile phone Redmi 14C 5G and 3) a sum of Rs. 220/- (rupees two hundred twenty) only were seized from the possession of **Ankit Rai 22 yrs s/o Raj Narayan Ray of Chhotka Dhakaich, PO-Barcka Dhakaich, District- Buxar, Bihar – 802133 a/p Hatta Golapati at the spot on the same day at 3.05 pm by preparing a seizure memo.**

Similarly, 1) one mobile phone I-Phone 11 having mobile No. 9234592072, and 2) a sum of Rs. 230/- (rupees two hundred thirty) only were seized from the possession of **Aman Kumar 21 yrs s/o Suresh Das of Joriyahi, District – Sitamardi, Bihar 843313 a/p Paona Bazar Hero Cycle at the spot on the same day at 3.10 pm by preparing a seizure memo.**

Accordingly, 1) **Ankit Rai 22 yrs s/o Raj Narayan Ray of Chhotka Dhakaich, PO-Barcka Dhakaich, District- Buxar, Bihar – 802133 a/p Hatta Golapati and 2) Aman Kumar 21 yrs s/o Suresh Das of Joriyahi, District – Sitamardi, Bihar 843313 a/p Paona Bazar Hero Cycle were arrested at 3.15 pm and 3.20 pm respectively by preparing arrest memos. The whole process of search and seizure was videographed in my eSakshya account. I took the signatures of the arrested accused persons and witnesses in the parent exhibits, weighing and seizure memo, seizure memos and arrest memos and I also put my signatures on the same.**

Hence, the arrested accused persons along with the seized items are handed over to you for taking necessary actions.
