12. First Information contents:- On 07/05/2025 L. N. Shangshak, S/o. L. Shangreiyob presently resident Shangshak Khullen, loaded Veneer goods under invoice no. 129, way bill no. 8216 8341 1780 on truck, WB75B 8439 at Mingthing Sawmill, Shangshak. The truck goods were entrusted to I).Sheetu Thapa (Transportation Agent), II).Seikh Hapijul (Driver) III).Seikh Sagar Ali (2nd Driver) IV).Ahmed Ansari (Driver Friend V).Lalbabu Das, Truck Owner for delivery, last contact was on 03/06/2026 at phoolbari, Siliguri,. Since then all accused are untraceable, mobiles swift off. Goods not delivered till date, causing wrongful loss. Isuspect criminal breach of trust, cheating and conspiracy by accused.

Hence, a case has been registered on under FIR NO. 01(6)SSK-PS/2026. U/S. 61/316(3)/318(4)/2(7) &3(5) BNS Act for investigations.

Subject: Complaint Regarding Missing Truck no. WB75B8439, Goods (Veneer) under invoice No.129 & E-way bill no.8316 8341 1780, Driver, Transportation Agent, and Truck Owner — Loaded on 07/05/2026 from Mingthing Sawmill, Shangshak.

Respected Sir/Madam,

I, the undersigned, hereby submit this First Information Report (FIR) before your esteemed authority with the earnest request to take immediate cognizance of the matter and initiate appropriate legal action at the earliest.

That on **07th May 2026**, a truck was loaded with goods consisting of **Veneer** at **Mingthing Sawmill, Shangshak**. The transportation of the said goods was entrusted to the transportation agents and the driver as detailed below:

That after the loading of the said goods, the last contact with the driver (Seikh Hapijul), the transportation agents (Sheetu Thapa and Joseph), and the truck owner (Lalbabu Das) was established on **03rd June 2026**, when the truck was reported to be at **Phoolbari (Fulbari), Siliguri**. Since that date, all the aforementioned persons have become completely unreachable and unresponsive on their respective contact numbers. Despite repeated attempts, none of them have responded to any calls or messages whatsoever.

That the consignment of Veneer goods loaded on the said truck has not reached its intended destination till date, and the whereabouts of the truck, goods, driver, agents, and owner are entirely unknown to me, causing me grave concern and financial loss.

That I strongly suspect that the said persons may have committed criminal misappropriation, cheating, and/or criminal breach of trust with respect to my goods, and may have intentionally absconded to avoid their lawful obligations.

In light of the above facts, I most humbly pray that your good office may kindly:

1. Register this complaint as a First Information Report (FIR) under the relevant provisions of law.
2. Initiate an immediate investigation into the matter and trace the whereabouts of the truck, goods, driver, agents, and owner.
3. Take appropriate legal action against the accused persons — Sheetu Thapa, Seikh Hapijul, and Lalbabu Das — under applicable sections of the Indian Penal Code / BNS.
4. Ensure recovery of the goods or their equivalent value at the earliest possible time.
