FIR Contents :- ASI. Moirangthem Rinash Meitei (Manipur Police Department, ANTF/IE), Imphal East District lodge a written report to OC HNG-PS stating that on 09/03/2026, at about 6:00 pm a reliable information was received from my own source about the frequent movement of certain individuals who was involved in the distribution of narcotic drugs and psychotropic substances in and around the locality of Mantripukhri area under the jurisdiction of Heingang Police Station. The said information was reduced in writing and was placed before Shri Ak. Sadananda Singh, Addl. SP (Traffic) Imphal-East (Nodal Officer ANTF Imphal-East) for executing the information into action. On approval of the source report, a joint team comprising of ANTF Imphal East Unit led by me along with Osacr-37 of CDO Imphal East Unit led by S.I. W. Ronny Singh were constituted for execution of the secret information. Accordingly, a random frisking and checking starting from 6:35 pm, was conducted in front of the NRL Oil Pump, located at Mantripukhri, Imphal East. In that, one unknown person carrying two suitcases, one in light blue colour and another one in dark green colour by holding on both hands came in a suspicious manner. The teams had observed his behavior for some time. Eventually, he was trying to hand over the said two suitcases to one another unknown person who came driving a Force Traveller T2 vehicle white in colour, bearing Reg. no. MN03B0239, previous Reg. no. AS02BC4782, Chassis No. MC1E4FBA1JP008714 and Engine no. D68001578. By seeing their suspicious behavior, they were detained at 6:40 pm on the spot i.e. in front of the NRL Oil Pump for further checking and verification. On preliminary verification, they identified themselves as (1) Aribam Mansish aged around 24 years, s/o (L) Md Tamijur, r/o Kshetrigao Awang Leikai, Imphal East and (2) Shajabam Aslam Khan aged around 32 yrs, s/o (L) Shajabam Abdul Jalin, r/o Kshetri Bengoon Awang Leikai, Imphal East. As per lawful procedure, we identified our identities as police personnel of ANTF, Imphal East and CDO/IE Unit.

Further, after informing Addl. SP/Traffic Shri Ak. Sadananda Singh (MPS) (In-Charge, Anti Narcotic Task Force/IE), the two suitcases were searched. The searched led to the recovery of 7(seven) nos. of packet in Light blue coloured suitcase weighing about 7.60 Kg, 8(Eight) nos. of packet in Dark green coloured suitcase weighing about 9 Kg, i.e. 15 (fifteen) packets of suspected Cannabis (Ganja) wrapped in transparent polythene from the two suitcases, weighing approximately 16.60 Kg (Sixteen kilograms and sixty grams) in total including the weight of transparent polythene. The recovered items were seized on the spot at 6:43 pm from their possession by following all legal formalities and both were arrested on the spot at around 6:50 pm. Furthermore, they disclosed that the said Psychoactive drug, Cannabis (Ganja) was picked up from one Dinesh Chingakhm aged around 24 yrs, s/o Ch. Bimol Singh, r/o Kongpal Khaidem Leikai, Imphal East to deliver at Dimapur for commercial purposes. After examining their statement, the teams approached to the above mentioned location for execution of Dinesh Chingakhm. On reaching his residence, located at Kongpal Khaidem Leikai, Imphal East, a preliminary examination was conducted and he admitted himself that he was involved in the above said illegal works. Therefore, he was also arrested on the spot at 7:35 pm as followed up action. Details of the seized items are as follows:

- 1) One suitcase light blue in colour containing 7(seven) nos. of packets suspected to be containing Psychoactive drug, Cannabis (Ganja), weighing about 7.60 Kilograms including the weight of transparent polythene and excluding the weight of suitcase.
- 2) One suitcase dark green in colour containing 8(eight) nos. of packets suspected to be containing Psychoactive drug, Cannabis (Ganja), weighing about 9 Kilograms including the weight of transparent polythene and excluding the weight of suitcase.
