She had stayed in a rented house owned by one Mr. Lenon Vaiphei at Vaiphei Veng, Mantripukhri near IGAR-S camp, IE.

However with the outbreak of the Manipur violence starting from 3rd May, 2023, they had abandoned their home on the night of 3rd May, 2023 itself and took refuge at the nearly IFAR South Camp. On the 10th May, 2023 they had been shifted to Kangpokpi. However, after staying for one week in Kangpokpi, they shifted to Shilong and then to Mizoram, where we stayed in a Relief Camp and then after some took months, stayed in a rented house in Mizoram. Now, he had been staying in Tuinom Khopi Village, Churachandpur, in a rented house.

In this regard, he would like to report that their abandon rented house was trespassed and all their household properties were either stolen or damaged by unknown miscreants during the month of May, 2023 itself. However, as they were displace and taking shelter in different places for their safety, they were in trauma and under such hardship, they had not have any idea of registering FIR regarding their grievances and hardships. However, the government is now planning to provide rehabilitation schemes for the IDPs for which registering FIR is made mandatory for availing such welfare schemes and programs. Hence the report.

However, after staying for one week in Kangpokpi, we had shifted to Shillong and then to Mizoram, where we stayed in a Relief Camp and then after some months, stayed in a rented house in Mizoram. Now, I have been staying in Tuinom Khopi Village, Churachandpur, in a rented house.

In this regard, I would like to report that our abandoned rented house was trespassed and all our household properties were either stolen or damaged by unknown miscreants during the month of May, 2023 itself.
