Brief of the case:

Today i.e 23/05/2026 at 03:45 p.m. a written complaint report is received from the complainant namely AS Wungnaoyo, Village Secretary, Roudei (TM Kasom) that on the Night of 22/05/2026 at 10:04 p.m., armed Kuki militant carried out an attack to Roudei (TM Kasom) village using sophisticated weapons. Due to the close proximity of the attack, bullets rained heavily upon the village, causing damage to several houses, including multiple tin roofs being struck by bullets. During the attack, the house of Mr. Ngaranmi Zingkhai was directly hit, particularly the roof of his residence. The life-threatening and premeditated attacks endangered the lives and safety of all the residents of the village.

Hence a regular FIR No. 33(05)2026 LTN-PS, U/s 109/324(4)/125/191(3)/351(2)/3(5) BNS and 25 (1-C) Arms Act is registered for investigation.

22nd May 2026.

Sir,

The Roudei (T.M. Kasom) Village Authority would like to place on record, for your kind perusal, that armed Kuki militants allegedly attacked the village at around 10: 04 pm on 22nd May 2026 using sophisticated weapons.

Due to the close proximity of the attack, bullets rained heavily upon the village, causing damage to several houses, including multiple tin roofs being struck by bullets. This is not the first such incident, as similar attacks in the past have also resulted in damage to residential properties. Unfortunately, during yesterday's attack, the house of Mr. Ngaranmi Zingkhai was directly hit, particularly the roof of his residence.

Such life-threatening and premeditated attacks endanger the lives and safety of all the residents of the village. Moreover, these acts constitute a serious violation of the Suspension of Operations (SoO) Agreement currently in force with the Kuki armed groups.

Therefore, we respectfully request your good office to register an official FIR and take necessary legal action at the earliest, as deemed fit under the law.
