Brief of the case:

Today i.e. 29/05/2026, a combined security forces comprising of Manipur Police, CRPF and BSF provided security to a convoy of stranded FCI trucks and LPG/IOCL tankers from Yaingangpokpi towards Ukhrul. At about 11:00 a.m., while the convoy reached cemetery area of Roudei (TM Kasom) village NH 202, the convoy came under heavy attack/ambush by unknown armed militant suspected to be the Kuki armed militant from Patleijang village area. As a result of the attack, an FCI Truck Driver, identified as Nitish Das, aged about 63, S/o Brindaban Das of Basudebpur, Umapally, Bansberia (M), Tribeni, Hooghly District, West Bengal - 712503, (Driver of Truck No. WB 15C/2403), sustained multiple gunshot injuries and succumbed to his injuries at the spot. During the process of extraction of the dead body by a police team led by OC/Litan PS, one Police personnel of Litan-PS namely C/No. 1905583 Disingam Maringmei sustained bullet injuries on his both legs, consequently the convoy escorting security teams retaliated and the exchange of fire ensued, which lasted for 3^{1/2} (three and half) hours.

Hence a regular case under FIR No. 35(05)2026/LTN-PS, u/s 103/109/121(2)/132/3(5) BNS, 25(1-C) Arms Act & 16/18/20 UA(P) Act is registered *Suo Motu* for investigation.

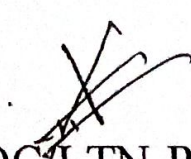
