Sir,

1. On 18 June 2026, inputs were received with respect to presence of armed cadres near 113 Border Pillar, Kultuk, Molvailup and likely chance of Inter Faction Clash (IFC) between unknown groups in general area Molvailup. Accordingly, own tps were deployed in general area 113 Border Pillar and Molvailup.

2. At approximately 0445 hours on 19 June 2026, while conducting Area Domination Patrolling near 113 Border Pillar in general area Molvailup (Grid Reference - 103907) own troops detected suspected move at shot distance. The leading scout challenged the suspected individual opened fire which was immediately retaliated with fire by troops of 11 Assam Rifles.

3. Due to dense vegetation, inclement weather and extremely poor visibility the unknown individuals could not be identified. Own troops fired and exchange of fire took place for approximately two to three minutes.

4. The hostile group subsequently disengaged and fled using cover of dense forest and poor visibility. During the search following has been recovered:

- 4.1. Fired Case Cartridge of 7.62 mm - 21 rounds.
- 4.2. Live Case Cartridge of 7.62 mm - 02 rounds.
- 4.3. Fired Case Cartridge of 5.56 mm - 11 rounds.
- 4.4. Live Case Cartridge of 5.56 mm - 03 rounds.

5. It is requested to take custody of above-mentioned ammunition recovered from the border area near Molvailup. An FIR may please be registered against the unknown cadres and thorough investigation be conducted on the subject please.
