The said Malemnganba who seems to be heavily drunk bullied complainant to call out his daughter as he have some words to talk with her. Thereafter, his family also rushed out to sort out what was happening. Then the said Malemnganba out of his hostile and wild nature drew out one pistol, started to bully and threatened to listen to him. On seeing the tense situation people who are in and around ran/ came forward to control the situation. The gun Malemnganba carried was grabbed in time and he escaped the situation. Hence the case.
