On observing the said persons, his team attempted to stop them for verification as their movement was in clear violation of the curfew order imposed by the DM, IE. However instead of complying, the said persons became aggressive and assaulted the Police team and also attempted to snatch the arms of the Police personnel. The miscreants were then detained and brought to Police Station for further verification. On preliminary inquiry they were identified as (i) Yangoljam Borish Singh (23) yrs S/o Y. Muhindro Singh of Heingang Makha Leikai (ii) Mangsatabam David Singh (21)yrs S/o M. Dolen Singh of Kontha Ahallup Maning Leikai (iii) Pangambam Nivash Meitei (22)yrs S/o P. Accordingly, they were arrested at 01:15am, 01:17 am, 01:19am, 01:21 am, 01:23 am, and 1:25 am, respectively, and handed over to OC/HNG-PS for further investigation. Hence, it is requested to register a

case against them under the provision of 221 BNS (Obstructing public Servant in discharge of public functions), 223 BNS (Disobedience to order duly promulgated by public servant) and 132 BNS (Assault or criminal force to deter public servant from discharge of his duty), & 304(2) BNS (Snatching of arms).
