Sir,

I have the honour to state a few words for your kind consideration and prompt action that my son-in-law, Karanjit Gupta S/o Jawaharlal Gupta, presently residing at Ngari Galli, Thangal Bazar, Imphal, and permanent resident of Vaishali District, Bihar, has been subjecting me and my family members to physical and mental harassment continuously for the past few years without any just cause.

1. That, in the month of December 2024, the said Karanjit Gupta kidnapped or abducted my youngest daughter namely Sohani Sahaa and kept concealed at Bihar to compel her marriage without her will. She was brought from Bihar by our family members. The matter had not been disclosed to others as he threatened to my family members that we will kill or hurt or cause problem if disclose it.

2. That, in the month of September 2025, we arranged marriage ceremony of Sohani Sahaa, he deliberately mislead the groom's family, due to which the marriage could not be solemnized.

3. That, as of now he has been threatening my daughter, Sohani Sahaa and my family members stating that he possesses obscene photos and videos taken by him during the time he kidnaped or abducted my daughter, Sohani Sahaa. He further threatens to upload the said material on social media platforms if she proceeds to marry any other person. On suspicion, I checked his mobile phone and found many photos of my daughter. I asked him to delete those photos but he refused to do it. Instead, he threatened me that the said photos will be uploaded in social media.

4. That, recently he also assaulted and harassed his wife namely Roshini Kumari (My eldest daughter) several times. However, the matter was resolved through family as they were husband and wife during the time.

5. That the above acts have caused grave mental agony, fear, and apprehension of danger to the dignity and reputation of my younger daughter and my family members.

I therefore request you to kindly register an FIR against Karanjit Gupta under the appropriate section of law.

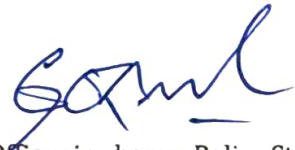
