Sir,

As per endorsement, I have enquired under GD. No. 22/City-PS/2026, dated 09/02/2026, on a complaint reported by M. S. Seilunreng, 29 yrs S/o. M.S. Thoiba Lamdangmei Village, Nungba Sub-Division, Noney District A/p. Langol National Game village Zone-III, B166, Imphal West regarding lost of one Honda Activa 4G, Pearl Amaz in colour bearing Regd. No. MN01AD-8731, Engine No. - JF50ET9020696, Chassis No. ME4JF50CMHT020755 which was parked at the compound of Treasury office, Imphal West under proper lock and key on 09/02/2026 in between 12:00 noon to 12:30 pm. During the enquiry, it is established that the said Honda activa has been stolen by unknown person. On hectic effort and the sources collected the involved accused person was identified as Sarangthem Tomba Meitei (46) of Yairipok. The said individual was arrested from the campus of Imphal Treasury Office on 25/5/2026 at 4:00 PM. On questioning, he identified himself as Sarangthem Tomba Meitei (46 yrs) S/O (L) S. Manihar Meitei of Yairipok Keisham Leikai and admitted that he had stolen the above mentioned Activa bearing Regd. No. MN01AD-8731 from the compound of Treasury Office, Imphal on 09/02/2026. He further stated that the said Activa had been handed over to one Md. Nawaz Sarif of Sangaiyumpham, Thoubal District in return for which he received an amount of Rs. 3000/- from Md. Nawaz Sarif. On body search found one L-shaped iron rod/tool (modified from Allen Key) and one key. The same has been seized from his possession by proper formalities at 4:10 PM. So, a regular case is needed to be registered for proper investigation.

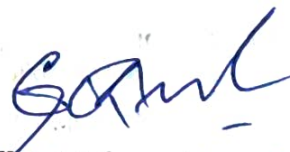
