12. First Information Contents. :- ASI M. Ajitkumar Singh of HNG-PS submitted an enquiry report to OC/HNG-PS stating that On minute perusal of the same report dated 20/04/2026, it is learnt that the complaint had alleged that on 06/04/2026 at about 01:00 pm, her house located at Khundrakpma Mayai Leikai, Imphal East was destroyed and subsequently looted valuable properties including cash amount of about Rs, 70,000/- (Rupees Seventy thousand), 4(four) gold necklace and 2(two) gold rings by a mob led by Asem Lanchenba (23) yrs S/o Asem Angangcha @ Sohara of Khundrakpam Mayai Leikai, Imphal East and some other unknown persons when she and her family members had gone outside of their home for some other work on the said day. Thereafter, she along with her family members could not enter and live inside their house because of many threats with false charges with wild allegations made by the family of the said Asem Lanchenba.

As per endorsement, he along with a team of Heingang PS led by him had visited the spot i.e. the house of the complainant at Khundrakpam Mayai Leikai at about 11:00 am of 26/04/2026 for enquiry. Immediately, on reaching at the spot, he had inspected the same and photographed the alleged sites. On physical checking, it was found that a large portion of GI sheet walls of the house where the complainant was partly destroyed and damaged and some household items.

In the course of enquiry, some of the local leaders namely (1) Tonjam Somorjit Singh (48) yrs S/o Late Ibocha Singh of Khundrakpam Mayai Leikai (Secretary YLL Club, Khundrakpam) (2) Ahongshangbam Khambi Devi W/o A Iboton Singh of khundrakpam mayai Leikai (Nishaban Secretary) were also examined and recorded their statements and stated that the incident happens out of some misunderstanding between the two families and there is no concrete evidences of looting of valuable articles including the gold ornaments needs to enquiry thoroughly among others.

In view of the facts and circumstances, he submitted the enquiry report with a suggestion to register a regular FIR case against Shri Asem Lanchenba and others for a thorough investigation for the end of justice. Hence the inquiry report.
