As per endorsement, an enquiry was conducted into the matter. During the course of enquiry, a reliable information was received that the missing person was kidnapped/abducted by four unknown persons from Mantripukhri area and the victim was being held captive at place called "Recovery Oasis" located at Mantripukhri bazar. Accordingly, teams of Heingang Police Station immediately rushed to the spot and successfully rescued the victim from the said place on 30/04/2026 at 02:00 pm.

During further enquiry, it came to learnt that the persons involved in the kidnapping/abduction were identified as: -
