Sir,

I have the honour to report that, today 15th June 2026 at around 3:20 pm received a reliable information that unknown person's is transporting a contraband drugs suspected to be a brown sugar along Teddim Road, Molnom village, CCPur. Without any delay an information was intimated/informed to SP-CCP and the SP-CCP instructed to form a strong Police team including Women Police and conduct a further necessary action. Immediately, a strong police team of CCP-PS lead by SI Shominthang Kipgen rushed towards Molnom village, CCPur along Teddim Road and set up one vehicle Check point (NAKKA). In the meantime, a requisition for deputing one Executive Magistrate to be present while conducting Frisking and Checking was submitted to Deputy Commissioner, Churachandpur. Immediately, one Executive Magistrate namely Mrs. Kimkhanching SDC/Tuibong was deputed for Magisterial Duty by Deputy Commissioner, Churachandpur.

While conducting frisking and checking at Molnom village, one unknown female individual was found moving in a suspicious manner at Molnom Village area carrying one bag. The Police team immediately stop the suspected person and the women identified herself as Mrs. Hoineilhing (32) w/o Lunkhosang Chongloi of Khonomphai Village, CCPur. She was informed that she need to be search by women police in the presence of Magistrate as she is

highly suspected to possess a contraband items. The women agreed to be search in the presence of Magistrate. However, due to security reason, the individual was brought to Police Station along with the black colour bag she was carrying. At CCP-PS proper search was conducted in the presence of Executive Magistrate. During the search, 4(four) transparent packets containing suspected brown sugar were recovered inside the black hand bag. The four plastic packets containing suspected brown sugar were weighted and marked as follows 1) A - 502 gms, 2) B - 504 gms, 3) C - 504 gms and 4) D - 504 gms, weighing 2014 grams all together. The contraband substances along with the mobile phone of the accused were seized under proper seizure memo in the presence of witnesses at CCP-PS.

The accused Mrs. Hoineilhing was arrested at 4:25 pm.


