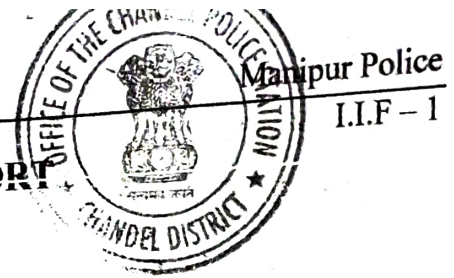

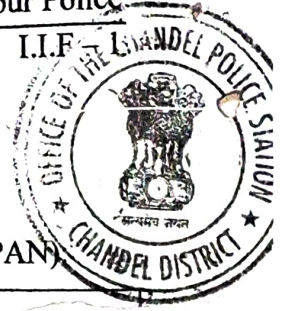

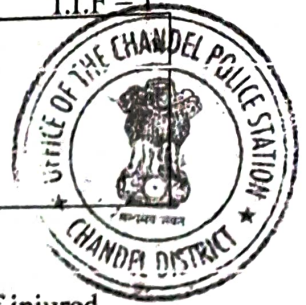

On 23rd May, 2026, the villagers of Charangching Khullen once again unlawfully entered the jurisdiction of Charangching Khunkha and Charangching Khunou villagers near Rengchit Louli Kreng/stream around ¾ kms from fire brigade. Upon receiving information in between 10:30 am to 11:00 am, the authorities of Charangching Khunou & Khunkha went to inspect the site. However, instead of cooperating, the villagers of Charangching Khullen physically assaulted them with stick with nails, spades, knives and catapults causing grievous injuries to several members.


