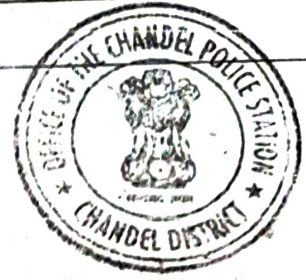

With utmost respect, it is submitted that on 23<sup>rd</sup> May 2026, at approximately 10:25 am, villagers of Charangching Khullen, who were lawfully engaged in community work at Moljam area, were violently attacked by villagers from charangching khubou and Charangching Khunkha villages, allegedly led and instigated by their respective chiefs, Namely Shri. Sn. Rakesh alias Thamong chief of Charangching Khunou, and Shri. Sk. Shetnong, chief of Charangching Khunkha along with their gangs (1) Sn. Kopera, S/o Sn. Thamdang, (2) Sn. Bungwar, S/o Sn. Darphung, (3) Sn. Khalminthang, S/o Jv. Shumwar, (4) Th. Mishra, S/o Th. Kamnung, (5) Sn. Loveson S/o Sn. Bungdon and (6) Sn. Bungdon, S/o (L) Sn. Dartho. the matter is greave in nature and the following fact are respectfully brought to your kind notice

1. The assailants, acting in furtherence of a common unlawful object, violently assualted several persons including women, cuasing serious injurious to Shri. Th. Goodson, and Smt. Db. Shangtin.

2. Shri Th. Goodson sustained greivous head injuries after being struck with a blunt object by Sn. Rakesh alias Thamong, chief of Charangching Khunou, and required immediate hospitazation at Chandel District Hospital where stiches were administered on his head.

3. On the same evening, the same evening, the MGNREGA cultivated farm established since 2007 was allegedly vandalized and destroyed by the said villagers, cuasing extensive destruction to cultivated orange, lemom, pineanpple, mango and stink bean tress/saplings, including farm fencing, resulting in substantial loss and heigtened communal tension in the area

4. Police personnel proceeding towards the place of occurance were wrongfully obstructed by villagers from Charangching Khunou and Charangching Khunkha villages and compelled to turn back, therby inteerfering with lawful discharge of official duties and disturbing maintenance of public order

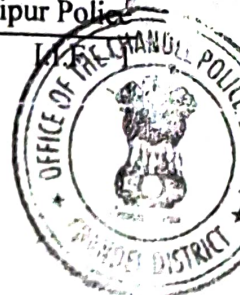


