Subject: Submission of report for registration of FIR case.

Sir,

I have the honour to state that, on the 28<sup>th</sup> May, 2026 at around 06:00 pm my mother invited me for a dinner together with my younger brothers. On arrival for dinner around 07:00 pm I had an argument with my father regarding guarding of our village in connection with the current situation in the state. In the middle of the argument one of my younger brothers namely HB. David Anal (23) S/o *HB.* Livingstone of Toupokpi village, Chakpikarong Sub-Division Chandel District Manipur threw punch on my face and using other deadly weapons resulting to a cut on my left eyebrow though he's not involved in the matter. Then, I saw my father hitting me in my back involving one of my younger brothers whom I could not identify him particularly. As I could not bear the pain and fear of more attack from them I ran out of the scene to resist more physical assault on me.

I therefore, request you to kindly register an FIR case against my young brother David Anal (23) S/o Livingstone of Toupokpi village as he is the person who interfered between me and my father leading to initiate physical assault on me.
