In submitting herewith the following report I, have the honour to state that on 26/05/2026 at 11.00 pm the five individuals namely 1) Jourul Hussein 27 yrs s/o Robijuddin A/P Yaioripok Changamdabi Mathak Leikai, Permanent Address Ahamadabad Village, PO & PS Kashimpur, Jiribam Dist. Manipur, 2. MD. Azam Khan 24 yrs s/o Md. Azad Khan of Yairipok Mathak Leikai, 3. MK. Wahidur Rahaman 17 yrs s/o MK. Najiruddin of of Yairipok Mathak Leikai, 4. Mk. Khurshid 18 yrs s/o MK. Azad Khan of Yairipok Mathak Leikai and 5.MK. Saheed Bharot 24 yrs s/o MK. Wahidur Rahaman of Yairipok Bamon Leikai, Thoubal Dist. were handed over to this P.S by Captain Affan of 43rd A.R, Sajik Tampak Battalion to the effect that the five individual had visited the BSNL tower site located inside the Chahmol Assam Rifle Post to collect the batteries of the mobile tower without proper documents however due to their suspicious nature they were detained by the 43rd Assam Rifles and handed over to CKG-PS for further necessary action.

In the course of inquiry it is learnt that Jourul Hussein 27 yrs s/o Robijuddin A/P Yaioripok Changamdabi Mathak Leikai, Permanent Address Ahamadabad Village, PO & PS Kashimpur, Jiribam Dist. Manipur, has been engaged by the contractor for construction and installing of BSNL tower at several place within Chandel District, Manipur including Chahmol Top, and on 26/5/2026 he led four others namely to Chahmol Top to removed some default batteries however they were detained due to their suspicious nature and handed over to this P.S. On further inquiry he Jourul Hussein 27 yrs s/o Robijuddin admitted that he along with Md. Azam Khan 24 yrs s/o Md. Azad Khan of Yairipok Mathak Leikai, Imphal East District, Manipur had stolen some BSNL mobile tower batteries approximate value Rs.2 (two) lakhs from Saibol Joupi under Molcham P.S Jurisdiction since few days backed and sold it off at Imphal. And on examination of Md. Azam Khan 24 yrs s/o Md. Azad Khan of Yairipok Mathak Leikai he too admitted to have stolen the mobile tower batteries at Aibol Joupi. Hence a cognizable offence is made out against the two individuals namely 1) Jourul Hussein 27 yrs s/o Robijuddin A/P Yairipok Changamdabi Mathak Leikai, Permanent Address Ahamadabad Village, PO & PS Kashimpur, Jiribam Dist. Manipur, 2. MD. Azam Khan 24 yrs s/o Md. Azad Khan of Yairipok Mathak Leikai, Imphal East

It is therefore, requested to kindly registered a regular case against 1) Jourul Hussein 27 yrs s/o Robijuddin A/P Yairipok Changamdabi Mathak Leikai, Permanent Address Ahamadabad Village, PO & PS Kashimpur, Jiribam Dist. Manipur, 2. MD. Azam Khan 24 yrs s/o Md. Azad Khan of Yairipok Mathak Leikai, Imphal East under relevant section of law for proper investigation.
