1. Int was received regarding the some miscreates trying to damage fence work on Indo - Myanmar Border (IMB) from Chandel District Police. On 30 May, 2026, a fence work protection party of 21 Assam rifles was deployed to provide security cover to the fence work party in General Area Border pillar - 71 near Thingphai Village. During area domination, at approx 1130 hours, the leading scout observed suspicious indicators in the vicinity of the fence alignment. Acting swiftly, the quick reaction team secured the area and started search. During subsequent search operation employing Deep search Detector, a concealed cache of war like stores was recovered from the area.
