Subject: Complaint against RS Kitchen, Governor Road, Paona Bazar Near HDFC Bank regarding derogatory and insulting and offensive remarks against Manipuri Hindu community.

Respected Sir,

We, the undersigned members of the Manipuri Hindu Brahmins, e All Manipur Meitei Brahmin Organisation (AMMBO) respectfully submit this complaint seeking legal action against the above named person for making highly objectionable and derogatory and offensive remarks targeting our religion and community

1. That on 24th April, 2026, the accused namely RS Kitchen, made certain derogatory, sarcastic, and offensive statements against the Hindu religion and its followers.

2. That the accused, through social media facebook, stated the following. **"Dear Narendra Modi ji Manipuris are all eating beef, hindu khatre me hai, Pis pay immediate attention: Bharatiya Janata Party (BJP) Amit Shah"** and on top of that he uploaded a plate of rice with non-veg dishes along with salad.

3. That the said statements were insulting to the religious beliefs and sentiments of Meitei Hindus particularly Brahmin community and those words are deliberate and malicious and intended to outrage religious beliefs/feelings and thereby promotisng disharmony and hatred between communities and moreover likely to hurt religious sentiments and disturb communal harmony. Such acts are not only deeply hurtful but also disturb public peace and communal harmony. There was deliberate intent on the part of the accused by deliberately posting on facebook to hurt religious sentiments of Mertei Hindu Brahmins. The accused has malicious intent to outrage religious beliefs and feelings. His words brings hatred and creates enmity amongst Manipuri community and brings excitement to public disorder.

4. That such acts of the accused person attracts offences punishable under Section 299 BNS, 353(2) BNS, 196 BNS

5. That the act of the accused has caused serious hurt to our religious feelings and may lead to public disorder if not addressed. It is therefore, we humbly request Your Goodself be pleased to

1. Register an FIR against the accused person,
2. Conduct a proper investigation into the matter,
3. Take immediate strict legal action in accordance with law,
4. Ensure such incidents are prevented in future

For the ends of justice.

We are ready to cooperate with the investigation. We trust that necessary action will be taken urgently to uphold the rule of law and protect communal harmony.

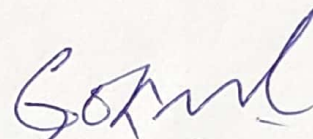

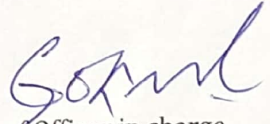
