Subject: - FIR for criminal intimidation by threat to cause death against Okram Benaral Singh, aged about 49 yrs., S/o (L) O. Ibohal Singh of Thoubal Kshetri Leikai, Thoubal District and his wife Lairenjam Shanti Devi.

Sir,

I beg to lodge this complaint against the above name accused person for committing the offence of criminal intimidation by threatening to cause the death of me and my wife.

1. That, on 17/05/2026 at about 7:00 am while I was at my residence at Masjid Road, Paona Bazar, Imphal, I received a telephonic call from my father-in-law. He informed me that Okram Benaral Singh, aged about 49 yrs and his wife Lairenjam Shanti Devi had conveyed through him that I and my wife Lairenjam Sushima Devi would be killed by him at any opportune moment. The threat was issued due to a dispute regarding a Lease deed for premises at Lamphel Sana Keithel owned by me.

2. That, in the days preceding 17/05/2026, I had also received multiple threatening phone calls directly from the accused persons, wherein he threatened to kill me and my wife.

3. That, on the same day at about 11:00 am, my wife elder sister namely Lairenjam Sangita Devi along with my mother-in-law visited my residence and informed us not to visit the lease premises as the accused persons are waiting to attack us with intend to cause us death.

4. That, due to the repeated threat received directly from the accused and through my relatives, my wife and I are under grave fear and apprehension of death. We are unable to live peacefully and have reasonable grounds to believe that the accused will execute the threat. Further, it is apparent that the accused threatened me and my wife to retain illegal possession of valuable commercial property at Lamphel Sana Keithel for his personal financial gain, thereby causing me wrongful loss and himself wrongful gain.



So, your esteemed authority is humbly requested to kindly take up immediate necessary action to arrest the culprits to punish them as per law for your ends.
