Sir,

I do hereby lodge this written complaint and state as under:

1. That today i.e. 4/06/2026 at 9:45 am, I had gone to the house of one Bagla located at Thangal Bazar, IW for my work as domestic help.
2. That while I was standing near the Iron gate of the said house, my husband namely Md. Islamuddin aged about 30 years S/o. Babu of Yairipok Kekru Makha, Thoubal District, Manipur suddenly came from behind, grabbed my neck and forcefully hit my head against the iron gate.
3. That due to the said assault, I sustained bleeding injury on my head and other injuries on my body.
4. That I raised hue and cry, where upon nearby public gathered at the spot and apprehended my husband. I was immediately rushed to RIMS hospital for medical treatment.
5. That I had been living separately from my husband for the past 2 ½ years due to matrimonial disputes. We are not legally divorced.

Therefore it is requested that an FIR may kindly be registered against him for the offences committed and necessary action be taken as per law
