I, hereby report that yesterday 6th June 2026 at 11:45 pm to 12:30 am of 7th June 2026 my father was beaten black and blue by three unknown persons without any provocation at Khoyathong, Naga Nalla near Emoinu Machineries, Imphal.

Before beating they communicated where does he live. He relied in Manipuri that he is born and brought up in Imphal.

They further said you Mayang when will you leave Manipur and go. Then three of them began to beat. He was beaten on nose, mouth (bleeding) and wanted to run but he fell. They then began to kick on his back.

As his dog was there and he shouted for is son (me). And then on this they absconded near Khoyathong Pukhri Achouba. Also his mobile is missing.

I would request police station to find out their whereabouts and justify us.
