12. First Information contents:

Manipur Police

On 24th April, 2026 at 10:30 a.m one Mr. Ngachonshang R. Shimray residence of Rarsonlang, ppangreitang East, Ukhrul, Ukhrul District, Manipur reported to this Police Station stating that on 22/04/2026 at around 10:15 a.m., his younger brother, Ngammeikhai R. Shimray, was electrocuted by a dangerously low hanging 33 KV MSPCL electric line near Langdang Village, Ukhrul District on NH-202 when the victim came into contact with the electric line. In the said incident, the victim sustained severe burn injuries on his face, head and feet and he was undergoing medical treatment. A powerful 33 KV line hanging dangerously low to the ground reflected serious direction of duty and failure to take mandatory safety precautions by the staff of MSCPL.

On receiving of the complaint report, a GD Entry No. 07/UKL-PS/2026 dated 24/04/2026 was registered for enquiry to establish the facts and circumstances of the case..

During the course of the enquiry, prima facie evidence could be made out against the accused persons. Based on the complaint report lodged by the victim and on the basis of the result of the enquiry, the GD Entry No. 07/UKL-PS/2026 Dated 24/04/2026 is converted to regular FIR No. 05(06)2026/UKL-PS US 125 (b) BNS, 2023 for investigation.

Subject: Complaint seeking registration of FIR and immediate investigation regarding electrocution caused by gross negligence of 33 KV MSPCL line**

Respected Sir

I, Ngachonshang R. Shimray, elder brother of Ngammeikhai R. Shimray, resident of Rarsomtang, Phungreitang East, Ukhrul District, Manipur, most respectfully submit this complaint seeking immediate registration of an FIR regarding a serious incident of electrocution caused by apparent gross negligence in the maintenance of a 33 KV transmission line under MSPCL.

On 22 April 2026 at about 10:15 AM, my brother, Ngammeikhai R. Shimray, was grievously electrocuted near Langdang Village, Ukhrul District, after coming into contact with a 33 KV live electric line hanging dangerously low, approximately four feet from the ground. Such hazardous condition clearly indicates gross negligence and failure to maintain mandatory safety standards.

The said incident did not occur by accident alone, but appears to have been caused due to gross negligence, recklessness, and failure of duty on the part of the officials/persons responsible for maintenance and safety of the said high-voltage line. A 33 KV line hanging at such dangerously low height reflects serious dereliction of duty and failure to take mandatory safety precautions.

As a result, my brother sustained critical burn injuries on his face, head and feet, and is undergoing medical treatment. Photographs and supporting materials evidencing the occurrence and injuries are enclosed.

The incident discloses commission of cognizable offences arising out of negligence endangering human life and causing grievous injuries, warranting immediate police intervention. I therefore request that your office may kindly:

1. Immediately register an FIR against the persons/officials responsible;
2. Conduct prompt and impartial inquiry/investigation into the incident, including spot inspection and collection of evidence;
3. Fix responsibility and initiate appropriate legal action against all persons found responsible for the negligent act and omission;

In view of the seriousness of the matter and continuing risk to public safety, I request prompt action in the interest of justice.

I shall be grateful for your urgent intervention.
